 - Send most recent official transcript in a sealed envelope from your high school registrar indicating grades and class rank to:

Official transcripts may be sent under separate cover but must also be **postmarked by the deadline of December 1, 2016**
 - You must be a graduating senior, meet high school unit requirements and have a 3.0 GPA (.3.0 or better GPA (on a 4.0 scale) or 90 or higher (on a 100 pt scale)

Your application to enter the Buc Days Scholarship Program, the \$10 application fee, official transcript and any other supporting documentation must be postmarked no later than December 1, 2016. You may also drop off your application packet in person at the Buccaneer office located at 1513 N. Chaparral St. no later than 5:00pm on December 1, 2016.
